Creating your first E-Learning Course

Don't be intimidated! With our help, creating great online courses is easier than you may think.

- **Step 1**: **The Big Idea** Choosing the topic for your course is not something to sweat about, it should be a topic you are knowledgeable and interested in. When deciding on a course topic, think about unique skills, design knowledge, industry techniques, and best practices that you incorporate in your everyday work. If you specialize in a field within your industry, or are a knowledge leader on a specific topic, people are interested in what you know.
- **Step 2**: **Learning Objectives** A learning objective is an outcome statement that defines specifically what knowledge and/or skills students will have once they complete the course. Make a list of the things that you think students should take away from your course. Learning objectives should be written in complete sentences that are relatively specific to the topics being covered.

Example: Participants will be able to calculate the total cost of materials through the use of proper construction estimating functions.

- **Step 3**: **Build the Outline** Take each of the learning objectives that you have for the course and make a list of ways the objectives can be met. How are students going to reach the objective? The outline should cover each section of the course, starting with broad subjects to be covered, and then adding in the detailed sections of each topic. This will be the road-map that you will use for organizing the information within your course. The more robust the outline, the easier it will be to stay organized while writing the course.
- **Step 4**: **Send Your Rough Draft to Us for Review** Once you have your course outline completed, and your thoughts and ideas are in place, let us help you polish the project. We want to be sure that the course you develop will meet the needs of state requirements for continuing education. A course that satisfies CE requirements generally sells the best.
- **Step 5**: **Be the Expert** This is the fun part! This is where you get to showcase your unique experience and knowledge. At this point, you have your learning objectives and outline written. Use the outline as a foundation to create a course narrative. As you elaborate on topics within your outline, explain them in as much detail as you can. You are writing about what you do and what you know. What is common knowledge to you could be extremely valuable to others. If you have pictures of jobs you have worked on, or graphics that could aid in student understanding, include them and explain what you are showing. Don't stress yourself out, work at your own pace, and take your time.

The lessons that you have acquired over the length of your career are extremely valuable, and likely unique. By starting with a topic you are knowledgeable on and passionate about, it will be easier to expand on the points you feel are most important.

State Requirement Fulfillment: Most states have specific education requirements for architects, contractors, pesticide applicators, and real estate agents. State regulatory agencies like to see courses that will help their licensees do their job within the requirements of the law. In many cases these education requirements can be met through online courses. If you have an idea for a course that would meet a specific state or national requirement, we can help you make that idea into a reality.

Specific Certifications: There are many state and national certifications that professionals in the construction trades may need. What we need from each Instructor

A detailed resume: This resume will be viewed by regulatory bodies. Please be sure to include all relevant experience that will set you apart as an industry leader.

A thorough course outline: Some regulatory bodies don't look at anything else, so it's important that the outline include all the topics covered. Please include a presentation length estimate for each section and the course as a whole.

A final PowerPoint presentation: This presentation needs to be fully edited and in final form before being submitted to us. A sample PP deck will be attached to this packet, which provides a basic template for our style and formatting (font, font color and font size).

A narrative of the course to go along with the PowerPoint slides: The narrative should expand on the points on each slide, but you do not need to read this information word for word when filming your presentation. Typically, a text version of the material will be loaded into the course just below the video presentation, providing students with multiple learning strategies.

Questions: We will need 20 questions per credit hour. * Please plan on a full 60 minutes of presenting time for each hour of the course. Questions need to be multiple choice with 3 incorrect answers and 1 correct answer. Please avoid True/False questions as much as possible. Questions do not need to be difficult, they are primarily meant to demonstrate that the student was watching the course.

* If the course is an Exam Prep course, the more questions the better. The course is preparing students for an exam, you should try to incorporate a variety of questions that tap multiple learning strategies: cognitive, affective and skill based.

Other things to consider:

Interactivity is a plus, i.e. hyperlinks to supplemental information, articles, vocabulary, etc.

The more useful (and marketable) course length is anywhere from 3 to 7 hours. When building your course, you can time it based on the average reading speed of 180-200 words per minute.

How filming happens: Once all presentation materials have been received, we will contact each presenter to schedule studio time. Presenters will be responsible for their own travel arrangements and costs, we will provide a hotel room for the days required for filming.

ARELLO Approval for Real Estate Courses

For real estate courses to be eligible for continuing education credits in several states, they must be approved by the Association of Real Estate License Law Officials (ARELLO). ARELLO approval is another layer of course review and approval and carries its own set of required documentation and structure. It will be helpful to keep the following requirements in mind as you are designing your real estate course.

Learning Objectives: ARELLO requires each distance course to contain two to three learning objectives per lesson. Where each lesson stops and starts is determined during the post production editing, but our editing team works to keep all related subject matter together in one lesson without exceeding 20-25 minutes per video. To make things as easy as possible for you, we would like to see two to three learning objectives per talking point/subject/topic. How these learning objectives are written is important, as ARELLO and many states frown at objectives that begin with "understand". Bloom's Taxonomy Action Verbs can be very helpful in writing these learning objectives. Many times, the learning objectives can be taken directly from the headers in your outline.

Incremental Assessments: ARELLO requires each distance course include an incremental assessment at the end of each lesson. ARELLO also requires that each incremental assessment have three separate assessments per lesson (topic). This means that for a five-question incremental assessment there will need to be 15 questions in the "assessment bank." If a student fails to pass the first assessment, they will be directed to an alternate assessment, which will contain different questions.

Justifications: ARELLO also requires that the student be provided with immediate feedback when each incremental assessment question is answered. This justification states what the correct answer is along with a short explanation of *why* the stated answer is the correct one. Students see these justifications after they submit their answer regardless of if their answer is correct or incorrect.

Final Assessments: As with the incremental assessments, ARELLO requires that there be a total of three final assessments for each course. Final assessments are usually 15-20 questions in length, which means the question bank needs to contain 45-60 questions. These final assessment questions need to be unique, or in other words, different from the questions used in the incremental assessments. Justifications are not required for final assessment questions.

References and Resources: Be sure to cite your sources! ARELLO requires each course application be accompanied by a References and Resources page.

Don't panic! At first glance, these requirements can appear overwhelming. As you write your course you'll be pleasantly surprised at how easily most of these items will be to create. If you have any questions or trouble along the way, please do not hesitate to contact us!
